Order

In exercise of the powers vested under Section 14(3) (a) of the National Council for Teacher Education(NCTE) Act, 1993, the Eastern Regional Committee grants recognition to **BNR Training College, Gulzarbagh, Patna, Bihar** for **Elementary Teacher Education Course** of one year duration from the academic session 2002-2003 with an annual intake of 50 (Fifty) students subject to fulfilling the following conditions.

1. The institution shall appoint / function with 5 teaching staff and supporting staff possessing the qualifications as laid down in the NCTE norms before the commencement of academic session 2002-2003, in the salary structure prescribed by the Central Government/ State Government as the case may be.
2. The existing 6 teaching staff already in service and not qualified as per NCTE norms shall acquire the qualifications as per the norms within a period of two years of this order.
3. The institution shall ensure Psychology laboratories and upgrade science laboratories within 30th September 2002.
4. The institution shall ensure Educational Journals, library and other instructional infrastructure as per the NCTE norms by 30th July 2002.
5. Renovation of the institution building should be done by 31st march 2003.
6. The admission to the approved course shall be given only to those candidates who are eligible as per the regulations governing the course and in the manner laid down by the affiliating university/ State Government.
7. Tuition fee and other fees will be charged from the students as per the norms of the affiliating university/State Government till such time NCTE regulations in respect of fee structure come into force.
8. Curriculum transaction, including practical work/activities, should be organised as per the norms and standards for the course and the requirements of the affiliating university/examining body.
9. Teaching days including practice teaching should not be less than the number fixed in the NCTE norm for the course.
10. The institution shall switch over to Two-year course from the academic session 2004-2005.
11. The institution shall continue to fulfill the norms laid down under the regulations of the NCTE and submit to the Regional Committee the Performance Appraisal Report within 45 days of the last examination/academic session every year. The Performance Appraisal Report should inter alia give the extent of compliance of the conditions indicated at 1 to 10 above.

If **BNR Training College, Gulzarbagh, Patna, Bihar** contravenes any of the provisions of the NCTE Act or the rules, regulations and orders made or issued thereunder, or fails to fulfil the above conditions, the Regional Committee may withdraw this recognition under the provisions of Section 17(1) of the NCTE Act.

The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.

A. Further, the recognition permission is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University Body, the State Government etc., as applicable.

B. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.

C. The institution shall maintain its website with hyperlink to the Council and the Eastern Regional Committee covering inter-alia the details of the institution, its location, name of the programme applied for with intake, availability of physical infrastructure, such as land, building, office, classrooms and other facilities or amenities; instructional facilities, such as laboratory and library, and the particulars of their proposed teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website, namely:-

- d) Sanctioned programmes along with annual intake in the institution;
- e) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph;
- f) Name of faculty members who left or joined during the last quarter;
- g) Names of students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
- h) Fee charged from students;
- i) Available infrastructural facilities;
- j) Facilities added during the last quarter;
- k) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
- l) The affidavit with enclosure submitted along with application;
- m) The institution shall be free to post additional relevant information, if it so desires;
- n) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognition.

D. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.

E. The institution shall make available list of students admitted on its official website.
